ITS MAJOR INITIATIVE IS A BRIDAL DRESS REPURPOSING PROJECT CALLED "ADORNED IN GRACE." DRESSES, WEDDING GOWNS AND ACCESSORIES ARE DONATED TO ADORNED IN GRACE BRIDAL SHOPS, WHICH RAISE AWARENESS AND FUNDS FOR THE CAUSE. VOLUNTEERS CLEANUP, REPAIR, AND REPURPOSE THE DRESSES, AND THE NET EARNINGS SUPPORT ENDING SEXUAL EXPLOITATION THROUGH PREVENTION AND RESTORATION WORK. THE MAIN PREVENTION PROGRAM FUNDED BY THESE SALES IS CALLED COMPASSION YOUTH MENTORING, AND IS A MENTORING PROGRAM FOR VULNERABLE YOUTH. THE ANTI-EXPLOITATION WORK HAD ABOUT 187 VOLUNTEERS WHO SPENT APPROXIMATELY 2,163 HOURS IN 2025 RAISING AWARENESS FOR THE PREVENTION OF TRAFFICKING AND SUPPORT FOR VICTIMS. APPROXIMATELY, 127

4b (Code: ) (Expenses \$ 272,316. including grants of \$ 33,456. ) (Revenue \$ ) COMPASSION CARE CENTER AZ: THE COMPASSION CARE CENTER IS A COMMUNITY RESOURCE CENTER THAT HELPS FAMILIES AND INDIVIDUALS MOVE FROM SURVIVING TO THRIVING BY CONNECTING THEM TO MULTIPLE LOCAL RESOURCES AND SERVICES UNDER ONE ROOF. THIS INCLUDES BUT IS NOT LIMITED TO PREGNANCY SERVICES, EMERGENCY FOOD BOXES, CLOTHING, EDUCATION AND JOB SERVICES, COUNSELING, LIFE SKILLS, AND MORE. IT AIMS TO SERVE PEOPLE WITH COMPASSION AND CONNECT THEM TO THE SERVICES THEY NEED. IT IS STRATEGICALLY LOCATED IN A COMMUNITY WITH MINIMAL OPTIONS FOR HEALTH, COUNSELING, JOB TRAINING, ETC. THE COMPASSION CARE CENTER IS A VOLUNTEER-LED MODEL THAT SERVES HUNDREDS OF PEOPLE A YEAR. IN 2025, 173 VOLUNTEERS SPENT 5,462 HOURS SERVING 1,098 INDIVIDUALS AND FAMILIES AT THE CARE CENTER.

THERE WERE MANY COMMUNITIES UNITING IN 3 STATES TO HOST 10 COMPASSION CLINICS INCLUDING 23 CHURCHES UNITING AND 1,919 VOLUNTEERS WHO VOLUNTEERED OVER 14,964 HOURS. THE CLINICS PROVIDED MEDICAL, DENTAL, CHIROPRACTIC, VISION, MAMMOGRAMS, ACUPUNCTURE, FOOT CARE AND OTHER SERVICES TO OVER 3,045 INDIVIDUALS IN 2025. THE ESTIMATED TOTAL VALUE OF CARE SERVICES PROVIDED WAS \$617,933.
